3. The ITC (HS) Classification had been revised w.e.f 01.01.2017. The ITC(HS) Codes/Export products as per ITC(HS) 2012 which were covered in Table 2 of Appendix 3B of FTP 2015-20 were harmonised with the ITC(HS) Codes/Export products of ITC(HS) 2017 on 07.03.2017. Subsequently, it has come to the notice of this Directorate that some of the HS Codes of 2012 had been bifurcated and subdivided/slightly





In order to provide coverage to all such products which were eligible for benefits as per ITC (HS) 2012, amendment is being made to Table 2 of Appendix 3B of FTP 2015-20 as notified on 07.03.2017 and modified on 22.08.2017 by providing coverage to the following products under ITC(HS) 2017.
