In pursuance to the orders of Deptt. of Revenue vide F.No.A.12028/12/2012-Ad.I dated 31.7.2012, assigning additional charge of the post of Chairman, CBEC to Ms Praveen Mahajan, Member and consequent upon acceptance of the request of Smt Sreela Ghosh, Member for voluntary retirement with effect from 04.09.2012, and the appointment of Smt Sandhya Baliga as Member, it has been decided with the approval of the competent authority to make the following modifications in the allocation of charge to the Members of CBEC, with immediate effect and until further orders.

The charge of Member (Computerization) and the Zonal charge of DG Systems is assigned to Smt Shanti Sundaram, Member, in addition to her regular existing charge as Member (L&J) and the existing Zonal charge of Chief Commissioners of Bangalore, Chennai, Cochin, Coimbatore and Mysore, CDR, Directorate of Legal Affairs, Settlement Commission, CESTAT and Authority for Advance Rulings.

5. The allocation of charge to other Members of CBEC will remain unchanged.
