2. Due to seniority dispute among the officers in one of the feeder grades for promotion to the grade of Assistant Commissioner, namely, the Customs Appraisers, it has not been possible to finalise the Seniority List of officers in the grade of Assistant Commissioners. For this reason, the names of the officers given above have been arranged in alphabetical order.

3. The promotions of the above mentioned officers to the grade of Deputy Commissioner of Customs & Central Excise is purely on ad-hoc basis and shall not confer any right on the officers so promoted for any claim for regular promotion in the grade and the period of such service shall not count for seniority or as qualifying service for further regular promotions.

4. The officers being promoted through this Order shall assume charge of the post of Deputy Commissioner in the same office in which they are currently posted.

5. The Chief Commissioners/DGs shall ensure that if any of the officer whose name figures in the promotion list is under suspension or facing any charge sheet or prosecution, he/she shall not be allowed to assume charge in the grade of Deputy Commissioner and this fact may be brought to the notice of the Board. Further, in respect of officers undergoing penalty, if any, the promotion may be given effect only after the expiry of the currency of the penalty in terms of DOPT's OM No. 22074/5/2004-Estt.(D) dated 15.12.2004.
