
The President is pleased to promote Shri Sriram R, Additional Commissioner of Customs and Central Excise for promotion to the grade of Commissioner of Customs and Central Excise in pay scale of Rs. 37400 – 67000/- with grade pay of Rs. 10000/- on provisional and ad-hoc basis, by including his name in the panel for the year 2013-14 at Sl.No. 37 A below Shri Akhil Kumar Khatri (Sl.No. 37) and above Shri N. Vishwanath Kulkarni (Sl.No. 38), notionally w.e.f. 06.01.2015 i.e. the date on which his junior Shri N. Vishwanath Kulkarni was promoted to the said grade and on actual basis w.e.f. the date of assumption of the charge of the post

2. The promotion to the grade of Commissioner of Customs and Central Excise is purely on ad-hoc basis and does not confer any right on the officer so promoted for any claim for continued officiation or regular promotion in the grade of Commissioner and the period of such service shall not count for seniority or as qualifying service for further regular promotions. Government reserves the right to terminate the ad-hoc appointment and revert the officer to the post from which he was promoted.

3. With the approval of the competent authority, Shri Sriram R, Additional Commissioner on his promotion to the grade of Commissioner is posted as Commissioner, ST-II, Bangalore, CX with immediate effect and until further orders.

4. Shri Sriram R must be relieved immediately and he must join at his new place of posting, under intimation to the Board. No representations whatsoever shall be entertained before he joins at his new place of posting.

5. The Chief Commissioner concerned shall send compliance report regarding relieving and joining of Shri Sriram R, Additional Commissioner to the Board **[with a copy endorsed to ADG (HRM-II), DGHDR]** by **07.10.2016**.
