OFFICE ORDER NO. 113/2016

The President is pleased to promote Shri Shambhoo Nath, Additional Commissioner of Customs and Central Excise in the panel for the year 2013-14, by including his name at Sl.No. 6A below Shri P.K. Behra (Sl.No. 6) and above Shri Ganesh Havnur (Sl.No. 7) in the approved main panel for promotion to the grade of Commissioner, Customs & Central Excise in the pay scale of Rs. 37400 – 67000 with grade pay of Rs. 10000/- on provisional and ad-hoc basis, notionally w.e.f. 06.01.2015 i.e. the date on which his junior Shri Ganesh Havnur was promoted to the said grade and on actual basis w.e.f. the date of assumption of the charge of the post, subject to outcome of the W.P. No. 5821/2008 pending before the High Court of Andhra Pradesh.

2. The promotion to the grade of Commissioner of Customs and Central Excise is purely on ad-hoc basis and does not confer any right on the officer so promoted for any claim for continued officiation or regular promotion in the grade of Commissioner and the period of such service shall not count for seniority or as qualifying service for further regular promotions. Government reserves the right to terminate the ad-hoc appointment and revert the officer to the post from which he was promoted.

3. With the approval of the competent authority, Shri Shambhoo Nath, Additional Commissioner on his promotion to the grade of Commissioner is posted as Commissioner, Mumbai (Audit-I), ST with immediate effect and until further orders.

4. Shri Shambhoo Nath must be relieved immediately and he must join at his new place of posting, under intimation to the Board. No representations whatsoever shall be entertained before he joins at his new place of posting.

5. The Chief Commissioner concerned shall send compliance report regarding relieving and joining of Shri Shambhoo Nath, Additional Commissioner to the Board **[with a copy endorsed to ADG (HRM-II), DGHRD] by 07.10.2016.**
